Subject: Urgent Indictment and Demand for Immediate Arrest of Benjamin Netanyahu and Senior Israeli Officials for War Crimes and Crimes Against Humanity in Gaza

Dear Prosecutor,

I hereby submit this formal indictment and urgent appeal to the International Criminal Court (ICC) for the immediate investigation, arrest, and prosecution of Benjamin Netanyahu, Prime Minister of Israel, and his senior government associates responsible for orchestrating and carrying out war crimes and crimes against humanity against the Palestinian civilian population in Gaza.

Recent actions by Netanyahu's administration, including the explicit plan to seize full control of Gaza City—where approximately one million Palestinian civilians are now forcibly concentrated following the occupation of 75% of Gaza territory—represent an egregious escalation of violence with catastrophic humanitarian consequences.

Netanyahu and his far-right coalition members have openly advocated for policies involving the forced displacement, ethnic cleansing, and systematic oppression of Palestinians.

Their decision to invade and occupy Gaza City under the justification of “eliminating Hamas” flagrantly violates international humanitarian law, including but not limited to the Geneva Conventions, the Rome Statute of the ICC, and universally recognized human rights.

These acts include:

Deliberate targeting and endangerment of civilian populations.
Forced population transfers and ethnic displacement.
Collective punishment of civilians for political and military objectives.
Threats to the safety and well-being of hostages and non-combatants.
Denial of humanitarian aid and essential services.

I demand that the ICC:

1. Initiate an immediate, thorough, and impartial investigation into these crimes.
2. Issue arrest warrants forthwith for Benjamin Netanyahu and all senior officials who have authorized, planned, or executed these acts.
3. Cooperate with international and regional authorities to secure their arrest and ensure they are brought promptly to justice.
4. Demand urgent measures to safeguard the rights and lives of the Palestinian civilian population in Gaza.

Failure to act without delay will be tantamount to complicity in these crimes and will undermine the credibility and authority of the ICC.
The people of Gaza and the international community look to the ICC to fulfill its mandate to hold perpetrators accountable and to deter further atrocities.

Thank you for your immediate attention to this grave matter.
